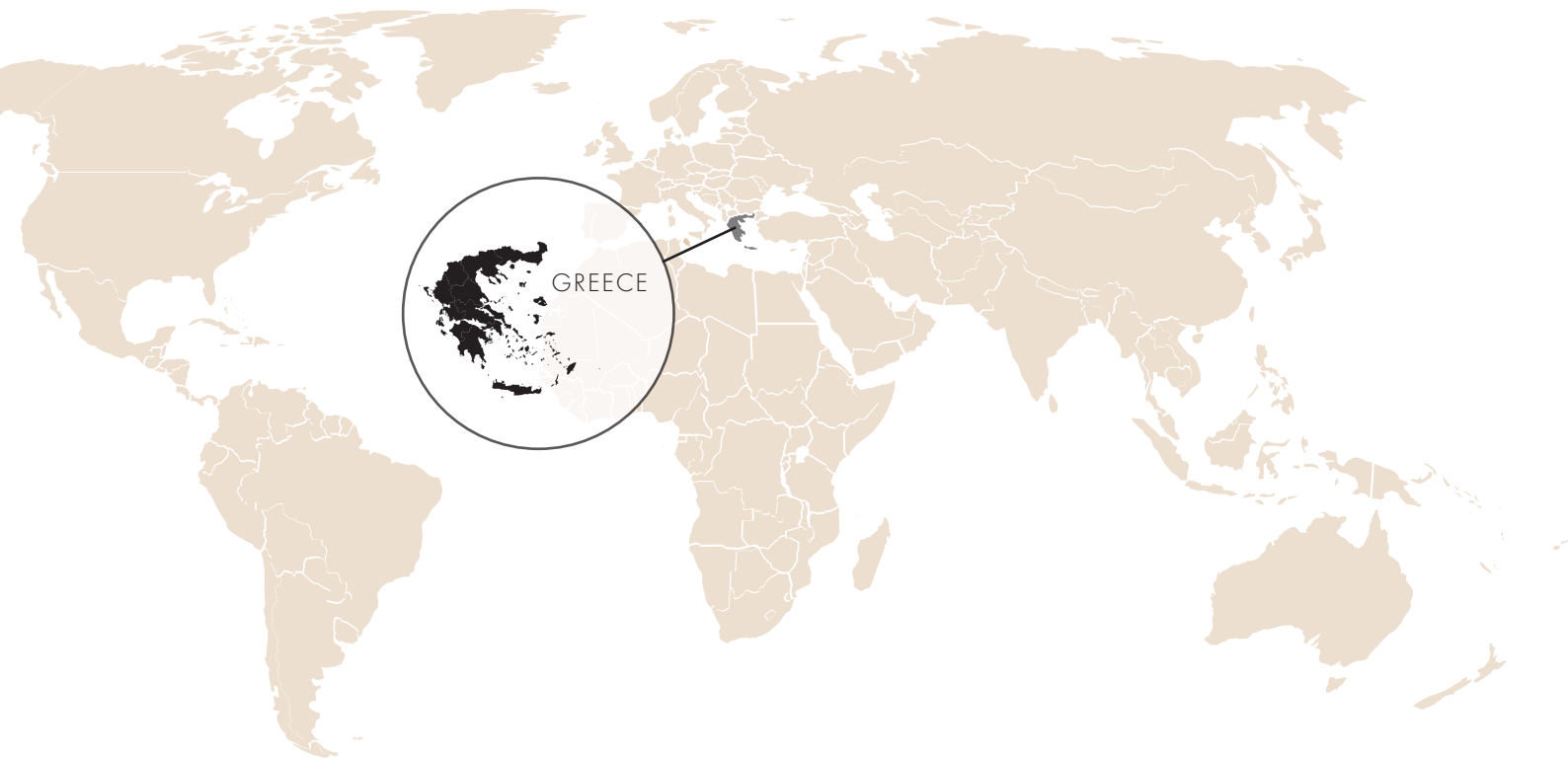
GOLDEN VISA PROGRAM


