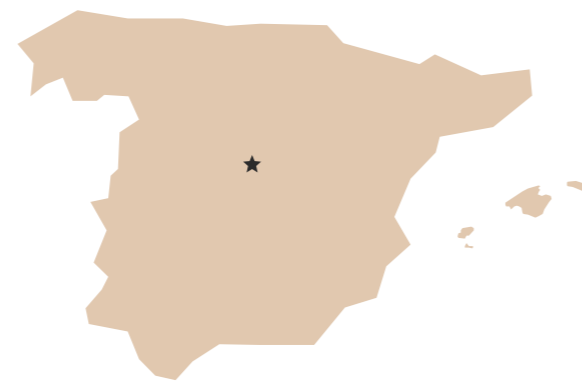
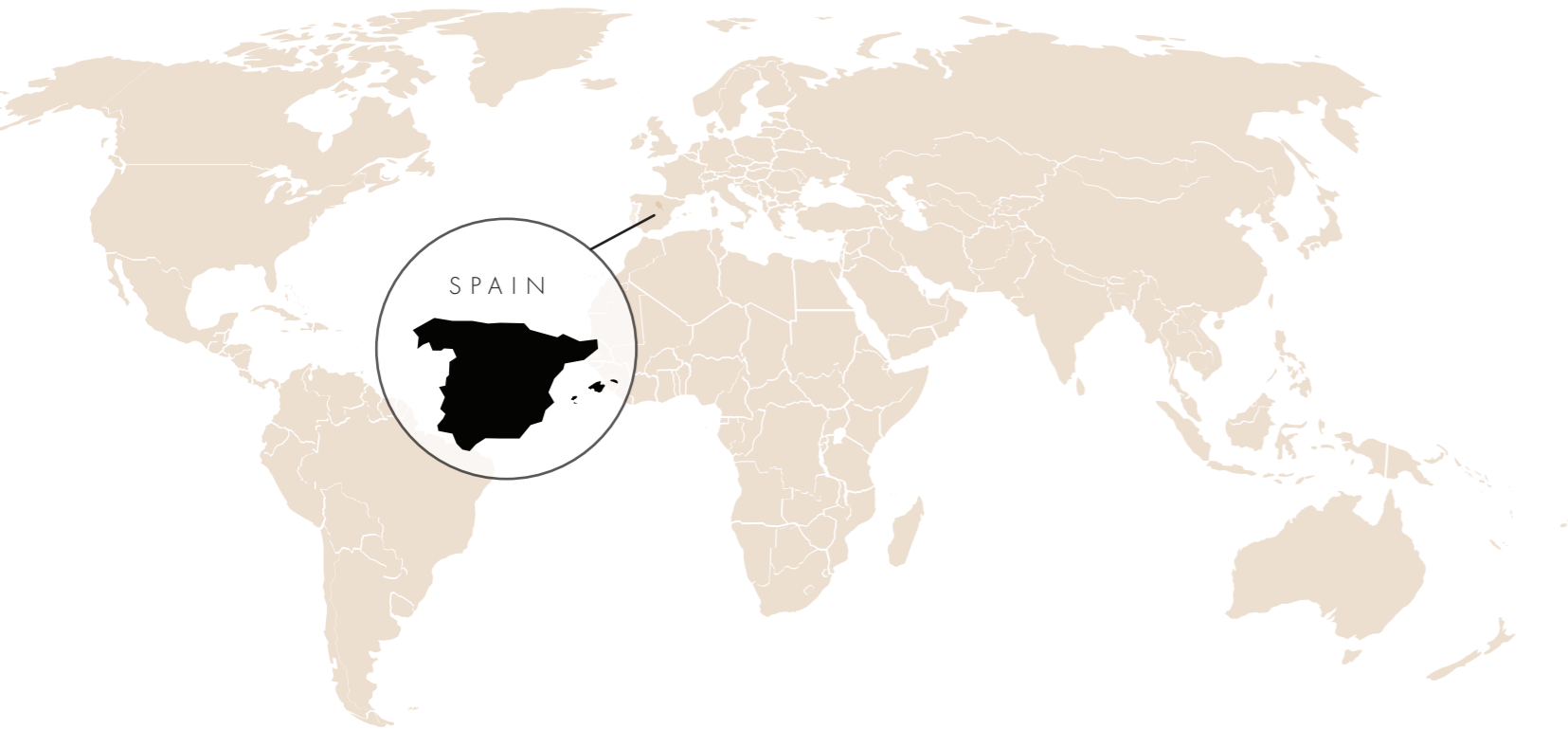
GOLDEN VISA PROGRAM
